CHAPTER ONE: The Roots of Isolation: Albania's Post-War Landscape

To comprehend the extreme isolation of Albania under Enver Hoxha, we must first cast our gaze backward, tracing the intricate threads of its history that wove a tapestry of vulnerability and fierce independence. Albania, a nation roughly the size of Maryland, has long been a crossroads of empires and cultures, its strategic position in the Balkans a double-edged sword that brought both external influence and continuous struggle for self-determination. For nearly five centuries, from 1385 to 1912, Albania was under the rule of the Ottoman Empire, a period that profoundly shaped its social, religious, and political landscape. World War II arrived on Albania's doorstep even before the official start of the global conflict. On April 7, 1939, Fascist Italy, led by Benito Mussolini, invaded and quickly occupied Albania. King Zog fled, and Albania became an Italian protectorate, effectively a puppet state. Mussolini saw Albania as a strategic foothold in the Balkans, a springboard for further expansion into Greece and a challenge to British influence in North Africa. During the Italian occupation, efforts were made to encourage Albanian irredentism in Kosovo and Chameria, integrating these Albanian-populated regions into a "Greater Albania" under Italian control.

Italian rule, however, was not unopposed. Resistance movements, largely communist-led, began to emerge. When Italy surrendered to the Allies in September 1943, Nazi Germany swiftly stepped in, occupying Albania to prevent an Allied landing. The Germans established a client state, but their control was also met with fierce resistance. The Albanian National Liberation Movement (LANÇ), a communist-led organization formed in 1942 and headed by Enver Hoxha, grew significantly in strength during this period. They engaged in guerrilla warfare, sabotaging Axis supply lines and rallying popular support.

The resistance struggle in Albania was not a monolithic effort. Besides the communist-led LANÇ, other factions, such as the nationalist Balli Kombëtar and the pro-Zog Legality Movement, also existed. However, the communists, with their strong links to Yugoslav partisans, ultimately emerged as the dominant force. By late 1944, the LANÇ had successfully pushed out the German forces, liberating Tirana on November 17, 1944, and the entire country by November 29, 1944. Albania holds the distinction of being the only European country to liberate itself from Nazi occupation without direct assistance from Allied ground troops.

The end of World War II found Albania in a state of profound devastation, both physically and economically. The country, already one of Europe's poorest, had suffered immense destruction. However, the war had also irrevocably altered its political landscape. The communist-dominated National Liberation Movement had solidified its control, and its leader, Enver Hoxha, quickly ascended to power.

On January 11, 1946, the People's Republic of Albania was officially proclaimed. The

newly elected People's Assembly, initially comprising both communists and non-communists, soon saw the systematic purging and execution of all non-communist members, establishing a communist monopoly on power by the end of 1946. The new regime moved swiftly to consolidate its position, targeting the middle class, landed aristocracy, and tribal chieftains. Hundreds were executed, and thousands more were sent to labor camps.

The post-war government wasted no time in implementing radical economic changes. They nationalized all forests and pasturelands, confiscated German and Italian assets, revoked foreign economic concessions, and brought all transportation under state control. A "war-profits tax" was levied against the more prosperous segments of the population, and the property of political opponents in exile was confiscated. These measures, while presented as necessary for reconstruction and the building of a socialist society, were also crucial in dismantling any potential centers of opposition and establishing the state's absolute authority.

Albania's immediate post-war period was thus defined by both the lingering scars of conflict and the swift, brutal establishment of a communist regime. The political vacuum left by the Axis withdrawal, coupled with the organizational strength and ruthlessness of the communist partisans, allowed Enver Hoxha and his loyalists to seize control decisively. This period, characterized by political purges and economic restructuring, laid the groundwork for the extreme isolation that would come to define Albania for the next four decades. The roots of this isolation were deeply embedded in a history of foreign domination, a fierce desire for national sovereignty, and the particular circumstances of a post-war landscape where a determined communist party was able to assert unchallenged authority.
